

The Carl Albert Center Congressional DEED OF GIFT

Gift of istorical aterials (non-Congressional)

- , (hereinafter referred to as the **DONOR**), hereby give, donate, assign and convey to the oard of Regents of the University of Oklahoma (hereinafter referred to as the University), historical materials, as per attachment A (hereinafter referred to as aterials).
- 2. Title to the aterials shall pass to the University upon their delivery to the University, including any and all right, title and interest the **DONOR** may have in the copyright therein, U. . or foreign.
- 3. ollo ing delivery, the aterials shall be maintained by the University in the Carl Albert Center (hereinafter referred to as the Center). At any time after delivery, the **DONOR** shall be permitted freely to e amine any materials during the regular orking hours of the Carl Albert Center.
- 4. The aterials shall remain closed to the public until the collection is processed. During this time the aterials shall not be made available for inspection, reading, or use by anyone, e cept the regular employees of the Center in the performance of normal archival ork on the aterials, and the **DONOR**, or persons authori ed in riting by the **DONOR** to have access to such materials.
- 5. The University, acting by and through the Center, may dispose of any of the aterials hich it determines, in its sole discretion, to have no permanent value or historical interest or aterials that are not included in the Center's collection policy. If in the sole opinion of the Center the aterials should be preserved in a different physical format, such as microfilm, the Center may perform the necessary processing and the original materials shall be disposed as the Center deems reasonable. The aterials may be disposed of at the Center's sole discretion provided during the lifetime of the the DONOR if the DONOR so chooses, the aterials proposed for disposal shall be offered to the DONOR.
