GENERAL TERMS AND CONDITIONS

Purpose of Use. The Borrower agrees that the Materials identified above shall be used exclusively for the specified purpose. Any other use is strictly prohibited.

Authority. The undersigned by the Borrower represents and warrants (s)he is authorized to execute this Agreement on Borrower's behalf and that the Agreement is enforceable in accordance with its terms and conditions.

Liability. The Borrower shall exercise the utmost care in protecting the loaned Materials from unauthorized use.

Assignment. This Agreement may not be assigned by Borrower without the prior written consent of the Center and any attempt to do so shall be void.

Source Credit. Borrower agrees to give source credits for use of materials in the production/publication. Such credits shall include and list appropriately "Julian P. Kanter Collection, the Carl Albert Center Archives." Except as stated herein, Borrower will not use the name of the Julian P. Kanter Political Commercial Archive, the Carl Albert Center, or the University of Oklahoma in connection with its production, distribution, advertising, or publicizing without the written consent of the Center.

Limitation of Use. With the exception of duplication necessary for processing the Materials for use in the specified production or publication (for which permission from the copyright holder must be obtained by Borrower), Borrower shall not duplicate, copy, upload, or post to the internet, distribute, loan, give, sell, or otherwise transfer the Materials or any part thereof to any other medium, person or entity. The Center shall observe all lawful Donor restrictions.

No Warranty. The Center and University extends no warranties of any kind, either express or implied, and assumes no responsibility for the ability of Borrower to use Materials, or the quality or performance of said Materials.

Indemnification. Borrower agrees to and does hereby indemnify, defend, and hold harmless the Center, the University, its Regents, employees, and agents from any and all liability for any claims, demands, suits, losses, damages, actions, or fees (including attorney's fees) of any kind whatever, caused by or arising out of Borrower's use of any Materials provided herein, including without limitation, claims of copyright infringement.

Copyright Disclaimer. It is expressly understood by the Borrower that while the Center owns the Materials, it does not own the copyright in the Materials and for purposes of this Agreement, expressly disclaims any copyright right in and to said Materials. The Borrower hereby agrees to assume full responsibility for acquiring all necessary copyright authorizations for Borrower's use of the content of these Materials from the proper copyright holders and such other entities as may be required.

Governing Law. The laws of the State of Oklahoma, *sans* its choice of law provisions, shall govern this Agreement and any legal action in connection herewith shall be filed in a court of competent jurisdiction in the State of Oklahoma, to which jurisdiction and venue Borrower expressly agrees.

Use Policy. It is the policy of the Center that the Materials are not used so as to bring disrespect, ridicule or public obloquy upon the candidates or producers of the Materials.

Endorsement. The use of reproductions of Materials from the Archive's collection does not imply that the Kanter Collection, the Carl Albert Center, or the University of Oklahoma endorse any product, enterprise, expressed opinions, or confirm the accuracy of any content in any publication, production, broadcast, website, or any other product in which such reproductions are used or cited.

Violation of Conditions. The Borrower acknowledges and agrees that violation of any of the terms and conditions of the loan agreement shall result in immediate termination of the agreement, and Borrower shall cease all use of the Materials.

Entirety. This Agreement contains the entire Agreement between the parties with respect to the subject matter hereof and may not be amended or modified except by a written agreement executed by both parties.
