Terms of Use for Objects from the Digital Collections of the Carl Albert Congressional Studies and Research Center:

- Published and unpublished materials may be protected by Copyright Law (Title 17, U.S. Code). Any
 copies of published and unpublished materials provided by the Carl Albert Center archives are for
 research, scholarship, and study purposes only.
- Use of certain published materials and manuscripts is restricted by law, by reason of their origin, or by donor agreement. For the protection of its holdings, the Carl Albert Center Collections also reserves the right to restrict the use of unprocessed materials, or books and documents of exceptional value and fragility. Use of any material is subject to the approval of the Curator.

For citations in published or unpublished papers, sound, moving image, photography, or any digital object herein, this repository should be listed as the Carl Albert Congressional Research and Studies Center *or* Carl Albert Center Julian P. Kanter Political Commercial Archive.

Exceptions to fees

In-state nonprofit organizations may also qualify for the waiver. Waiver requests must be in writing. Please include your federal or state tax identification number. Proof of credit must be supplied before a fee can be considered for waiver.

POLITICAL COMMERCIAL USE, FEES, AND PUBLICATION

Academic Use of Materials \$100 per groups of 20 commercials (40 commercials = \$200.00)

For the archive's purposes, an academic institution is an educational institution that grants degrees and issues diplomas or other certifications. Patrons making "academic" requests must demonstrate affiliation as a student (please specify graduate or undergraduate), faculty, or staff member at such an institution.

Non-Academic Use of Materials \$100 per groups of 20 commercials

Requests for non-academic or commercial use will be evaluated on a case-by-case basis.

Loan Fees - Loan fees are for the temporary loan only of the material and are used to maintain the collection and equipment.

- Fees for "clean" copies of commercials for production are based on the length of the commercial:
 - o Up to 30 sec: \$300 per commercial
 - o 31 sec to 15 min: \$600 per commercial
 - o 15 min or longer: \$750 per commercial
